Grace Elizabeth Ludwig Day, age 94, died Wednesday, Aug. 13, 2008, at St. Mary's Hospital in Rochester. Grace was born Jan. 25, 1914, in the Henry and Henrietta DeMann Ludwig farmhouse west of Millersburg, Minn. She began her education at the country school knowing only German and was the first in her family to complete high school, receiving her diploma in Northfield in 1932. In those hard economic times, Grace was recommended for the intense normal school program in Faribault and completed the one-year certificate to teach all grades and subjects in country schools. She taught in the one-room school that stood in the oak grove at the bend of Rice County Highway 1, northeast of current Interstate 35. During WWII Grace moved to Minneapolis, where she worked in the accounting department at the Northern Pump armaments factory. Following the war she took a clerical position in the engineering office of the Maico Hearing Aid Company in Minneapolis. In August of 1954 Grace wed George Kallevig and became a homemaker at his farm north of Willmar. After George's death in 1961 she continued to live in Willmar until 1964 when she moved back to the Dundas area. In July of 1966 she married retired Randolph farmer Don Day. They moved from Grace's mobile home to a house in Northfield in 1973, shortly before Don died. For the rest of her life Grace continued a pattern that was already well established of maintaining close contact with and support for her sisters, extended family and numerous friends. Grace loved many activities, but fishing, gardening, traveling and antiquing were close to the top of her list. She was active in her churches and was instrumental in rechartering the German Union Cemetery, where she will be buried. Family, friends and faith were Grace's constant focus during her long and active life. Grace is survived by her five nephews, Dennis (Mary) Henry of St. Peter, Minn., Carl (Mary Caroline) Henry of Northfield, Walter (Cynthia) Henry of Pittsburgh, Pa., Lawrence (Susan) Henry of St. Paul, Minn., and James Henry of Houston, Minn.; two nieces, Rebecca (Robert) Baron of Scotia, N.Y., Laurie Anderson of Cannon Falls, Minn.; two step-children, John (Pat) Day of Randolph, Minn., and Karen (Noren) Nelson of Edina, Minn.; three step-grandchildren, Michael, Matthew and Daniel (Kasumi) Day; and other relatives and friends. She was preceded in death by her husbands, George Kallevig and Donald Day; parents; infant brother, Carl Ludwig; five sisters, Gretchen Ludwig, Irene Younker, Lucille Spencer, Marjorie Henry and Joyce Anderson; step-grandson, David Day; and niece, Carol Bakule. Funeral services will be 11 a.m. Monday, Aug. 18, 2008, at Christ United Methodist Church, 27490 Gaylord Ave., Randolph, with the Rev. Dan Horn officiating. Interment will be in German Union Cemetery in Forest Township. Visitation will be from 2 to 5 p.m. Sunday, Aug. 17, 2008, at the Benson & Langehough Funeral Home in Northfield, and will continue one hour prior to the service Monday at the church. Casket bearers will be Chuck DeMann, Dennis Henry, Carl Henry, Walter Henry, Michael Day, Matthew Day and Daniel Day. Music will be provided by Lawrence Henry and Linda Hagen-Kvambeck. Memorials are preferred to Christ United Methodist Church of Randolph, First United Church of Christ in Northfield, or the German Union Cemetery Association.
