JOSEPH REMICK DIED FRIDAY MORNING AT THE HOME OF HIS DAUGHTER, MRS. KATHERINE STEHLEY, AT 615 WEST FIRST STREET, OF ADVANCED AGE. MR. REMICK WAS 88 YEARS OF AGE. HE HAS LIVED WITH HIS DAUGHTER FOR THE LAST FOUR YEARS. BEFORE MOVING TO THIS CITY HE RESIDED ON HIS FARM NEAR FOX LAKE. HIS WIFE DIED SEVENTEEN YEARS AGO. HE LEAVES TO MOURN HIS DEATH FOUR SONS AND FOUR DAUGHTERS: HENRY, OF FOX LAKE; JOSEPH, OF HIBBING, MINN.; JOHN, OF MENTOR, MINN., AND GEORGE, OF RED LAKE FALLS, AND MRS. CHARLES WILLIE, OF HAMPTON, MINN.; MRS. CHARLES EBERT AND MRS. CHARLES DAMANN, OF FOREST TOWNSHIP, AND MRS. KATHERINE STEHLEY, OF THIS CITY. THE FUNERAL SERVICE WAS HELD AT THE IMMACULATE CONCEPTION CHURCH SATURDAY MORNING AT 10 O'CLOCK. THE BURIAL WAS MADE IN ST. JOHN'S CEMETERY, NEAR HIS OLD HOME AT FOX LAKE.
